**Thursday, April 11, 2024** – The New York State Cannabis Control Board will hold a public meeting of the Board at 10:00 a.m. on **Thursday, April 11, 2024 at City University of New York Graduate School of Public Health & Health Policy (CUNY SPH), 55 West 125<sup>th</sup> Street, 7<sup>th</sup> Floor Auditorium (SPH-708), Harlem, NY 10027**. Board Member Jessica Garcia will be joining via live stream from a private location due to extraordinary circumstances.
